92. To ratify the recommendations of the informal meeting held by Zoom on 11<sup>th</sup> January 2022

It was proposed by the Chairman to ratify the recommendations, seconded by Cllr Winterbourne and resolved unanimously.

93. Change to BPC authorised signatories:

It was proposed by Cllr Winterbourne to morally support NSP's campaign and offer an initial payment of £500 in order to view the report. This was seconded by Cllr Hollyoake and resolved unanimously.
