19. Adoption of Previous Council Meeting Minutes:

It was unanimously agreed to approve and support the application but there were concerns about the lack of traffic management and parking on the road leading to the pinch point in the road sometimes being blocked when functions were on at the Hall & Cricket matches. Action: Clerk to advise Planning of the decision with the following conditions required: Adequate form of traffic management to allow full access to the junction to allow access for residents and emergency vehicles.

2022/0789/FUL Erection of 1no. 4 bed dwelling house with annexe. 18 Warminster Road Beckington Frome Somerset BA11 6SY

After hearing representation from the architect and discussion it was decided on a vote to oppose the application due to the fact it was outside the development area of the village. 3 councillors abstained.

2022/0790/LBC Minor amendments to application 2020/0546/LBC including the construction of two masonry piers in the rear modern extension to support the leaning wall, the omission of the enlargement of an existing opening of the South elevation and the reduction of size of one new opening on the East elevation.

21. LPP2 adoption

22. Parish Council's Accounts:

A) Budget to Date

Cllr Bishop has at last been able to gain access to Scribe, the accounting software and the locum clerk also has access but no knowledge of the system. Cllr Bishop hasn't been able to get a statement because full access to the Nat West accounts is only possible by visiting a branch. Delays in changing the details on the account and signatories have resulted in Nat West raising an internal complaint and £50 compensation.

23. New Bus Shelters on Frome Road

Cllr Winterbourne updated the meeting on ACE Shelters propositions for shelter and cycle rack and the meeting agreed that the shelters in the quote previously circulated looked as if they would be suitable for the locations.

24. Cycling and Walking LCWIP

Cllr Hollyoake updated the meeting on the current situation. The tubes measuring traffic were due to go down this week but the A36 / Rudge road was closed so they were delayed. The idea is to monitor who is using which route and in which direction during rush hours in particular. There is a meeting arranged fro 15th June at the Memorial Hall 3 – 8pm which Cllr Hollyoake and Patrick have organised. A questionnaire will also be sent out to residents.

25. <u>Area of Outstanding Natural Beauty</u>

Cllr Winterbourne proposed that as Cllr Brooke had not been able to find anyone to help he should find a consultant who would be able to advise BPC on what is required to achieve AONB status. This approach was agreed by all the Councillors.

26. <u>Flytipping</u>

The site in Rode has been almost cleared although there are some tyres still remaining as ownership had not been established. All agreed that the tips and recycling centres should be open to all and possibly without charge. Action: Clerk to email Adam Boyden and Dawn Denton, the newly elected Somerset Councillors.
