# **FULL COUNCIL MINUTES**

Minutes of the Full Council meeting of Beckington Parish Council held on Tuesday 9<sup>th</sup> April 2024 at 7.00pm in the Beckington Memorial Hall, Bath Road, Beckington, Frome BA11 6SH.

**PRESENT:** Cllr Paula Fox (Chair), Cllr Kevin Bishop, Cllr Clive Winterbourne, Cllr Liz Wright and Cllr Rory Ingleby-MacKenzie.

**ALSO PRESENT:** Ward Cllr Denton, one member of the public and the Parish Clerk.

Prior to the start of the meeting fifteen minutes was allowed for questions and comments from members of the public.

### 171. APOLOGIES FOR ABSENCE

There were no apologies. All members were present.

### 172. DECLARATIONS OF INTERESTS

No Declarations of Interests were made.

### 173. MINUTES

Council considered the minutes and **RESOLVED** to formally approve and adopt the minutes of the Council meetings held on Tuesday 12<sup>th</sup> March 2024.

It was agreed to consider the following application and to invite the resident in attendance to address the Council.

Comment: Following discussion it was **RESOLVED** to delegate authority to

Cllr Liz Wright and Cllr Rory Ingleby-MacKenzie to develop a full response and to request that the Planning Authority consider providing an extension to the consultation period so that Council could consider a final response at its meeting on Tuesday 14<sup>th</sup> May 2024. Concerns included the overbearing nature of the proposal, over-development of the site, height, loss of light, conservation area location, detrimental to neighbouring properties, the increase in the overall footprint and lack of

consultation.

# 174. NEIGHBOURHOOD PLAN

Council noted the following update regarding the Neighbourhood Plan:

- The surveys had been distributed and Cllr Winterbourne had been collecting the various collection boxes;
- To date 60 online responses had been received and over 100 hard copies;
- 82 people attended the launch event;
- Feedback prioritised favourite views, the protection of green spaces, features that made the parish unique, the conservation area, its historic buildings and protection of grade 1 agricultural land.

It was noted that the grant received from Localities amounting to £7,929 had now been spent and a further £1,626.48 expenses from Council balances had been incurred.

Council agreed to outline the expenditure incurred to the NPSG and to request that all future expenditure must be approved by Beckington Parish Council prior to any orders being placed. It was further agreed to request a budget from the NPSG to understand what future costs would be incurred alongside a progress report on the development of the Neighbourhood Plan.

Comment: Whilst as a Parish Council we understand that we were not

formally notified of this application and were not required to comment we have a serious concern. If the retail outlet and café go ahead then this will inevitably lead to increased traffic on Rudge Lane and most likely an increase in traffic volume to Goose Street in Beckington. Rudge Lane is itself narrow and there are frequent problems with two way traffic. Goose Street has much on-street parking as well as being narrow and the already obvious problems with traffic movement would be made much worse. As such we hope our comment will be taken into

consideration before the matter is determined.

existing stables with similar timber buildings.
