Minutes of the Beckington Parish Council meeting to be held on Tuesday 12th November 2024 commencing at 6:30pm in the Beckington Memorial Hall, Bath Road, Beckington, Frome BA11 6SH.

PRESENT: Cllr Paula Fox (Chair), Cllr Anne Owen, Cllr Clive Winterbourne, Cllr Liz Wright and Cllr Rory Ingleby-MacKenzie.

ALSO PRESENT: Ward Cllr Boyden, 3 members of the public and the Clerk to the Council.

Prior to the commencement of the meeting Council was asked whether it would provide a series of planning reasons related to planning application 2024/1865. It was confirmed that it would.

Cllr Boyden provided a number of updates which included the following items:

- Somerset Council had commenced a consultation with staff regarding a reduction in the workforce and potential redundancies;
- Somerset Rivers Authority SRA is going to launch a Community Flood Action Fund on December 10th 2024. It is expected to be oversubscribed. It was agreed to consider applying for funding to help address issues with the culvert behind the allotments;
- The SRA was also providing support for the development of a Flood Prevention Plan and a Flood Action Plan;
- A request had been submitted for planning application 2024/1865 to be determined by the Planning Committee. It was noted that the deadline for comments had extended.

Council thanked Cllr Boyden for all his work.

92. APOLOGIES FOR ABSENCE

There were no apologies. It was noted that Ward Cllr Denton had submitted her apologies.

93. DECLARATIONS OF INTERESTS

There were no interests declared.

Council was requested to consider co-opting Anne Owen on to the Parish Council. It was formally **RESOLVED** to co-opt Anne Owen on to the Parish Council. The Declaration of Acceptance of Office was duly signed.

It was further agreed to start Council meetings at 6.45pm as some Members were struggling to attend at the new time.

94. MINUTES

Council **RESOLVED** to formally approve and adopt the minutes of the Beckington Parish Council meetings held on Tuesday 8th October and 23rd October 2024.

95. NEIGHBOURHOOD PLAN

- (a) **Progress Update –** The following report was noted:
 - The Chair had now stood down but had remained a member of the Steering Group;
 - It had been agreed to have a rota of Chairs;
 - Concern was expressed regarding the news that an application for 70 homes in Congresbury initially refused had been overturned by the Planning Inspector despite a Neighbourhood Plan being in place with site allocations. Holt was also mentioned;
 - Somerset Council would be sending out a Call for Sites as part of its review of the Local Plan in the near future;
 - The Beckington Plan call for sites consultation will close on 29th November 2024;
 - The Plan's Vision and Objectives had now been drafted and would be consulted upon on 23rd January 2025;
 - The Local Green Spaces assessment was currently being undertaken.
